## **AYLLUSUYU REGISTRATION POLICY**

Please take the time to read this as it will help to ensure your place in this sacred journey.

- Why is it so important that you send in your registration with deposit quickly? That is because your deposit purchases your airline tickets. The price of airline tickets is subject to change, quite literally, from day to day. The sooner I have your deposit, the better are the chances we will have the best airfare available. I can't book our flights until we have a firm group of six people as that is the minimum number of participants. This number is subject to change. So send it in right away.
- The travel document, which is also the registration form, must be received well in advance of the journey. You can print it for you to fill out and send in.
- **About your deposit,** nothing happens with it until I book the airfare. The air travel doesn't get booked until I have six people registered with deposit and then it is used to pay for the airfare. It is held in an account until it is used to pay for the airfare. It is not used for anything else. If the airfare is less than the deposit, the balance is applied to the cost of the journey. If the journey is canceled, then the refund of the deposit is made in its full amount because it has not been used for the airfare. No worries about this because your money is kept secure. You can pay by check, money order, cash, or by credit card. If you want to pay by credit card or cash, you can do that through Pay Pal. You can pay by credit card through Pay Pal. (The name to find us on Pay Pal is apusalkantay@aol.com. Be aware that, because of the servicing fee that Pay Pal charges, Pay Pal will deduct that from the amount you are sending. The Pay Pal fee should not be deducted from the amount you are sending which is the deposit for the journey, pays your airfare and ensures your place in the journey. You can check with Pay Pal as to what their fee is and add that onto the payment/deposit so you can ensure that it is in full. If the Pay Pal fee has been deducted, the amount of that fee will be added onto your balance.) If you would like to pay by check or money order, you can do that. Checks and money orders should be made out to Fran Russo and sent to the mailing address shown below.
- Your deposit must be received quickly when it has been set. Otherwise, it is likely we will lose the airfare price and the cost will have to go up.
- The number of participants is limited to sixteen. The only way you will be definitely registered in the group that is going is by registering with deposit. YOU HAVE TO TELL US THAT YOU ARE COMING BY REGISTERING AND SENDING IN YOUR DEPOSIT. Don't wait to find out how many people have registered before you do. The only way we can know how many people are coming is by each registration with deposit. Please call me at 732-533-7276 to register and to ask any questions you may have. My e-mail is apusalkantay@aol.com as well.
- As I will be coordinating all flights to and from Peru, it's necessary that I have your flight numbers as well as arrival and departure times for your flights to and from the connecting airport. I suggest that you don't book your flights until I have booked our group flights to and from Peru. That way, you can coordinate your flight times with that. As soon as I have received the minimum number of registrations with deposit, I will book the international and in-Peru flights. Then I will give the flight information to our group. We will be meeting at an airport in the USA to fly to Peru and return to the USA to that airport. When you do book your flights to and from the airport where we will meet for our flight to Peru, please be sure to book your arriving flight three hours before our flight to Peru. For your departing flight, it is good to book that flight, at least, an hour and a half after our arrival back into the USA. That is because we will have to go through Customs and

Immigration. That can take some time depending on the number of people from the incoming flights who have to go through the process.

- In the case when six people have not registered and less than that number still want to go, we can do that. The difference is that the costs go up for both the land arrangements and the airfare. Those numbers are calculated by the number of people who would then be going.
- Full payment of the journey cost must be received, at least, one month prior to the journey's first date. I have to wire that money to our contact in Peru. That can take up to two weeks to clear the banks in Peru and be in their accounts. This pays for all our arrangements, such as lodging, land transportation, guides, and many other details. Payment information is in the travel document/registration form. Never let the cost of a journey stop you from coming. Payment arrangements are available.
- If you live outside of the United States, there are a few ways for you to send in your deposit and make payments. It is important that we talk, either by e-mail or by phone, so that I can tell you what those ways are and about flight arrangements. As it may be easier for us to meet in Peru, it can be arranged that we meet at Jorge Chavez International Airport in Lima. Your flights coming from and returning to your country would have to be coordinated with our flights from the United States. I have Skype so we can have our conversation that way. A ninety-day visa will be issued upon entry into Peru for people with a USA passport; that may not be true for people from other countries. If you are traveling with a passport from a country other than the USA, please call the Peruvian consulate nearest to you and inquire about visa requirements for the USA and for Peru.
- You will receive a packing list and pre-departure information upon receipt of your registration with deposit. Please be sure that your passport is up to date and, if it is not or you don't have one, I suggest that you get it updated or apply for one now.
- Give me a call so we can have a delightful conversation about this extraordinary journey. In this way, we can meet and I can answer any questions you may have. After I have received your registration with deposit, you will get the pre-departure document that will give you a lot of the information you will want to know. I can be reached at 732-533-7276.
